What is the General Convention (GC)?

- The **ultimate temporal authority** (*Worldly Governing Body*) of the Episcopal Church.
- **Bicameral Legislature** meets every three (3) years. (*Except in pandemics*)
- Composed of deputies (House of Deputies) and bishops (House of Bishops) from each diocese; each house has a presiding officer.
- 850 deputies and all bishops, retired or not.
- Legislation needs to pass both houses to become actionable.







GC makes the initiatives of dioceses and churches – what's happening on the ground level – official and actionable across the denomination.



GC80 Resolutions - highlights

RACIAL RECONCILIATION:

A125 – Establishment of Episcopal Coalition for Racial Equality and Justice / Specifies a 1/10 draw to fund efforts.

A127 – Telling the Truth about The Episcopal Church's History with Indigenous Boarding Schools.

A126 – Review and correction of the Prayer Book for colonial and racist language.

A129 – Forensic audit to better understand the historical origins of Church assets.





Why does it matter?

GC80 Resolutions - highlights

PRAYER BOOK/LITURGY:

D025 – Queen Lili'uokalani, Lesser Feasts & Fasts; referred to interim body.

CREATION CARE:

A087 – Calls the Episcopal Church to commit to a goal of net carbon neutrality by 2030.

SOCIAL JUSTICE:

D083 – Affirms all Episcopalians should be able to access abortion services and

birth control with no restriction.

A003 – Urges all dioceses to adopt a uniform paid family leave policy.




CHURCH GOVERNANCE:

A138 – Allowed for Legislative Committee meetings to occur before General Convention.

LAND ACKNOWLEDGEMENT

How can you be involved?

Did you know <u>any person</u> in our church can use the channel of our diocesan convention to introduce legislation?

- Good Standing.
- Church delegation may sponsor.
- Diocesan Convention passes resolution -> goes to General Convention (GC).
- At GC given to relevant committee; if passed, it moves to House of Bishops or House of Deputies, depending on legislation type.
- **If passes** one house, **must then pass** in the sister house.

Passes = what began as a grassroots resolution in a congregation, becomes legislation of The Episcopal Church.
